KENNEDY KRIEGER INSTITUTE ROAR FOR KIDS 2018 LIABILITY WAIVER

- 1. In consideration of being permitted to participate in Kennedy Krieger Institute's ROAR for Kids ("ROAR") I, the undersigned, for myself, my personal representatives, assigns, heirs and next of kin, freely acknowledge and realize the dangers and risks of participating in ROAR and fully assume all risks of personal injury and property damage that may result from such participation including but not limited to:
 - A. With Respect to 5K Run and Fun Walk: collision with pedestrians, vehicles or runners/walkers, and/or fixed or moving objects, the negligence of other runners/ walkers, sponsors, promoters or drivers, and dangers arising from falls, road surface, equipment failure, inadequate safety equipment, and weather conditions, as well as the possibility of physical and/or mental trauma (or injury). I understand that the route requires running/walking on public roadways open to the public and automobile traffic upon which the hazards of travel and traffic are to be expected and may involve running/walking in bad weather.
 - B. With Respect to Walking on the Nature Trails: injuries caused by (i) terrain, (ii) slips and falls caused by terrain, (iii) the forces of nature including temperature and weather, (iv) contact with a rock, log or tree, or other natural or man-made object, (v) the acts of wild or domestic animals, and (vi) the negligence of other walkers, sponsors, or promoters. All of these risks include the possibility of physical and/or mental trauma (or injury). I understand that the route requires walking on unpaved trails and may involve hiking in bad weather.
- 2. I realize ROAR requires physical conditioning and I represent that I am in sound medical condition capable of participating in the 5K run or fun walk or walk on nature trails, as applicable, without risk to myself or others.
- 3. I agree to follow all traffic laws, posted signs, rules and regulations.

Trail Walkers:

- 1. I understand that I will be walking on trails at Oregon Ridge Park and that these trails are through the woods and are not paved.
- 2. I understand that all markings and upkeep of the trails are the sole responsibility of Baltimore County and the Baltimore County Department of Recreation and Parks.

All Participants and Attendees:

- 1. In consideration of being permitted to participate in this event, I release for myself, my heirs and personal representative and the undersigned registrant under 18 years of age (minor), Kennedy Krieger Institute and its directors, officers, employees, volunteers and staff as well as Baltimore County, its County Executive, its County Council and Council members, and its employees, volunteers and staff (each an Indemnitee), from any claim, liability, demand, action and cause of action whatsoever (collectively, "Claim") arising out of or related to any loss, damage or injury (collectively, "Loss") to myself or my property, that I may sustain in connection with, or arising out of this event.
- 2. If registrant is a minor, I (as a parent or guardian) agree to indemnify and hold harmless each Indemnitee against any Claim for any Loss said minor may sustain in legal or other expenses incurred in connection with any Claim by or on behalf of said minor for such loss.
- 3. I consent to Emergency Medical Treatment if I am injured.
- 4. I understand I may be photographed at this event or during related activities, and I agree to allow my photo, video or film likeness to be used for any legitimate purpose.
